MOLSON CANADIAN PRESENTS OILERS GAME DAY LIVE 2021-22 SEASON SEATS CONTEST ("Contest")

OFFICIAL RULES

- 1. **SPONSOR:** This Contest is conducted and sponsored by Oilers Entertainment Group Canada Corp. and Molson Canada 2005 (collectively, the "Sponsor").
- 2. CONTEST SUMMARY: This Contest is held between October 21, 2021 and April 26, 2022 (the "Contest Period"). There is 1 Prize available to be won in this Contest, as described in paragraph 10 (the "Prize"). To enter, Eligible Entrants must follow the details in accordance with paragraph 6 below. Eligible Entrants shall be selected for the chance to win the Prize in accordance with paragraph 7 below. The Selected Entrant will win the Prize as defined herein.
- 3. ELIGIBILITY: To be eligible for this Contest, you must be at least 18 years of age, and a resident of Canada, excluding Quebec ("Eligible Entrant"). You are not eligible if, at any time during the Contest Period, you are an employee or partner of the Sponsor or a member of the immediate family (defined as mother, father, brother, sister, son, daughter, husband or wife, regardless of where they reside) or household of any of the above persons, their respective affiliates, agents, licensors, associates, representatives and advertising agencies. All decisions regarding eligibility to enter this Contest will be determined by the Sponsor in its sole discretion. This Contest is void where prohibited by law.
- 4. NUMBER OF PRIZES AND CHANCES OF WINNING: There is 1 Prize available to be won in this Contest. The Prize is described in paragraph 10 below. The chances of winning the Prize will depend on the number of Eligible Entrants who participate in accordance with these rules during the Contest Period. The value of the Prize is approximately \$19,000.00 CAD.
- 5. **CONTEST SCHEDULE:** This Contest commences on **October 21, 2021** and closes on **April 26, 2022**. Entries must be received by the Sponsor before the end of the Contest Period for a chance to compete to win the Prize. The Contest locations are described on the Contest website.
- 6. HOW TO ENTER: No purchase is necessary to enter this Contest. To enter, Eligible Entrants must: (1) register to attend a Molson Canadian presents Oilers Game Day Live Event ("Contest Event") either through the Official Edmonton Oilers website or in person at a Contest Event; (2) attend the corresponding Contest Event and confirm attendance by checking in with Contest Event staff before the end of second intermission of the applicable Oilers Game (each an "Entry"). The list of Contest Event dates and venues is available from the Molson Canadian presents Oilers Game Day Live page on the Official Edmonton Oilers website: www.edmontonoilers.com/gamedaylive and is subject to change. An Eligible Entrant may earn a maximum of 1 Entry per person, per Contest Event. Illegible, incomplete, late or garbled Entries will be disqualified.

Once submitted, Entries become the sole property of the Sponsor and will not be returned. No mechanically reproduced or photocopied Entries will be eligible for the Contest.

7. CONTEST DETAILS:

<u>Finalists</u>. The Sponsor will identify 20 Eligible Entrants through a random draw held on April 21st, 2022 to participate in the Finale Event. Eligible Entrants will receive 1 Entry into this draw for every point they received at a Contest Event (prior to the Finale) during the Contest Period. The 20 Eligible Entrants will be contacted directly following the random draw and qualified as finalists ("the "Finalists") to participate in a series of contests ("the "Final Competition") during a final Molson Canadian presents Oilers Game Day Live event on April 26, 2022 at Midway, 6107 104 Street NW, Edmonton, AB T6H 2K8 (the "Finale"). In no instance, will the number of Finalists exceed twenty (20).

Finalists must check in with an Oilers Orange and Blue Ice Crew member at the Finale by 4:30 pm Mountain Time, if any Finalist does not check in they may forfeit the opportunity to participate in the Final Competition. Sponsor reserves the right to provide limited flexibility for the check in time provided that the Final Competition has not commenced. All decisions regarding eligibility to participate in the Final Competition will be determined at the sole discretion of Sponsor. The Final Competition will include a series challenges determined at the sole discretion of Sponsor.

<u>Prize.</u> The Finalist who wins the Final Competition during the Finale (the "Selected Entrant") and has complied with these Official Rules will be the winner of the Prize (the "Winner).

If necessary, should the Prize be unclaimed, or should the Selected Entrant be unwilling, unable or ineligible to win the Prize as set out in these Official Rules, the Prize will be forfeited and the Sponsor shall have the right to select another Selected Entrant.

Sponsor reserves the right to provide limited flexibility for the check in time provided that the Final Competition has not commenced. All decisions regarding eligibility to participate in the Final Competition will be determined at the sole discretion of Sponsor.
- 9. DECLARATION OF WINNERS: The Selected Entrant will not be declared a Winner until:
 - (a) The Sponsor has determined that the Selected Entrant is an Eligible Entrant pursuant to these Official Rules;

PRIZES: There will be 1 Prize consisting of 2 season seats for Edmonton Oilers pre-season and regular season home games played at Rogers Place during the 2022-2023 hockey season valued at approximately \$19,000.00 CAD. The Prize does not include any opportunity to purchase the season seats or right of renewal.
